My calling to become a CASA volunteer was nothing bold or loud - It was more a matter of hearing a small voice in my head or heart that kept pushing me persistently, and then when I started to respond having everything fall into place.

Back in 2014, I'd been retired for 3 years and was involved in several worthy causes. But I still found myself checking the BEE's "LEND A HAND" column each Sunday to read about organizations' needs for volunteers. One with an intriguing title caught my eye- COURT-APPOINTED SPECIAL ADVOCATES (CASA ) OF STANISLAUS COUNTY. The article explained that CASA volunteers advocate for foster children in our county. That sounded like a very worthy cause. So I continued reading the description.

It explained that a CASA volunteer works specifically with one or several foster children and serves as each child's voice and as the judge's eyes in court hearings. It involves getting to know the child and spending time with him or her several times a month, to be their friend, but also to take

note of the child's situation and treatment in the foster home and progress in school, and so on, and then to write up the findings in a formal court report to be read by the judge before each 6-month hearing. That report would include my recommendations on the child's placement and other matters. The idea of making recommendations and supporting them before a judge sounded very intimidating to timid me. I had no experience with court proceedings and I wondered if I'd be able to handle something like that.

So I pretty much dismissed the whole idea, but I kept on noticing that article in the newspaper 's weekly column. Finally, I decided to attend an orientation meeting-no strings attached. There I learned more about the job, and I again suspected that it wasn't for me. We were asked to schedule a one-on-one interview with a staff person as the first step in joining the program. It turned out that I'd be in Pennsylvania when the interviews were to be held-a perfect out for me. As I headed for the door, the trainer asked why I hadn't signed up for an interview and I explained that I'd be gone at the times available. She offered to schedule a later appointment with me right after my return

from PA. So what could I say but OK-still no strings attached.

At the interview I admitted my doubts that this position was a good fit for me. She encouraged me to take the training with the assurance that I was free to drop out at any time. I learned that the trainers would be observing each of us trainees as they got to know us and would be judging whether we had what it would take to do the job. Then there would be an exit interview where we would mutually decide whether I should become an advocate. There would still be no strings attached-not until the judge swore me in after the training was completed.

So I began the training with the thought/hope that surely something would come up that would be a perfect excuse to drop out. But after the 6 weeks of training I was still there. At my exit interview I was encouraged to accept the challenge-and after some prayerful consideration, I did. In December 2014 I was sworn in by Judge Amaral-stepping far out of my comfort zone.

The following month my case manager helped me choose my first case. She told me about an 8-year-old boy in a foster home on a ranchette in Valley Springs. He was on the adoption track with his foster family, so it would be a simple case that would end happily as soon as the adoption was finalized. A great easy starter case.

So, just over 3 years ago I met the young man I'll call Robby. We hit it off just fine-all seemed good. But less than a month later, the apple cart was upset. Robby was exhibiting troubling behaviors - especially at school-and his foster parents decided they were too old to commit to raising a problem child. So all of a sudden the adoption plans ended and Robby was moved to another foster home. That was the beginning of a tough heart-breaking year of moves and turmoil for Robbie until he was placed in his current foster home. The 2 years since then have had their ups and downs but currently Robbie is thriving & happy. And I'm still his advocate.

So that's how I was called first to take the CASA training, then to be sworn in and finally to take on a "simple" case that has turned out to be very demanding. Despite all my doubts and foot-dragging, I'm glad now that I accepted that call.

Preparing for our devotion today I was thinking about the work we do. A lot of our activities are social, fun and entertaining. I was thinking how does our work apply to church and our Christian beliefs?

I thought about what we understand about Jesus and his life. There are a few instances that we know about where he went off by himself. One of these moments was in the beginning of his ministry where he was tempted by Satan. Another was near the end of his life when he went by himself into the garden to pray. I am sure there were other times he was alone as well.

But it seems to me over all he led a very social life. He gathered up 12 disciples to start with. He talked to a lot of crowds. He went to parties at people's houses. It seems more often than not he was with a lot of people.

I think we need a lot of socialization too. Like Jesus we humans today need the interaction and the connectedness that we can only receive from others.

We minister to very healthy active people and some, because of health issues, that are less active. We provide social stimulation. But, even more than that we provide mental stimulation because of the wide variety of activities we plan. We lead people to think about things and take them places that they have never thought about before. These new experiences create mental stimulation by opening all of us up to the wider world. We need to be social and we need to keep learning. At the same time our activities have brought people into our community of faith. Our work is very much a part of the program of the church. We are following the example set by Jesus and we too are setting examples for others. Yes, our program is very social like Jesus' life was, but like his life it provides much more to so many. 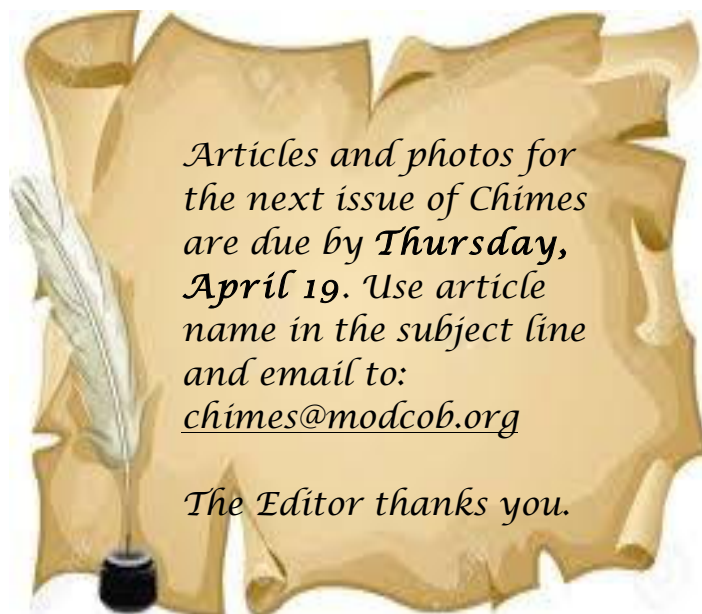
